1. North Harbour Aquatic Reserve

At the Ordinary Meeting of Council held on 18 February 2008, it was resolved that:

"Consistent with previous representations to the State Government, Manly Council write to the Minister responsible for Marine Parks and Aquatic Reserves, The Hon. Verity Firth, seeking:

- i) to extend the boundaries of the North Harbour Aquatic Reserve to include both Little Manly, Manly Cove and North Harbour; and
- ii) to develop a detailed Conservation Management Plan for the expanded Reserve."

The proposed letter to notify the Minister for Climate Change, Environment and Water, of the Council's intentions arising from the above resolution is appended. Refer to Attachment 1.

Council staff have commenced the development of a submission in line with the resolution. Feedback received from the state government indicates that approval for the extension of the Reserve would depend on evidence of thorough planning processes and community backing. Consequently, staff will seek community support through Precincts and public submissions in the coming weeks and anticipate a report back to Council in May or June 2008. A copy of the submission will be tabled at this time and will specifically note Council's desire to still allow recreational fishing within the proposed aquatic reserve.

Re: Council Motion to seek expansion of North Harbour Aquatic Reserve

At its Services Planning & Commissioning meeting on 14 May 2001, Council resolved to make a submission to NSW Fisheries (then the agency responsible for Aquatic Reserve design and management) to expand the North Harbour Aquatic Reserve to include Little Manly Cove, Manly Cove and North Harbour, and to increase conservation measures within the Reserve. The proposal did not proceed at that time.

Council is aware that recent changes to State legislation and associated portfolios have resulted in the relocation of the responsibilities for Marine Park management to Department of Environment & Climate Change. As such Council, at the Ordinary Meeting of 17 March 2008, moved that:

*Consistent with previous representations to the State Government, Manly Council write to the Minister responsible for Marine Parks and Aquatic Reserves, The Hon. Verity Firth, seeking:

- i) to extend the boundaries of the North Harbour Aquatic Reserve to include both Little Manly Cove and North Harbour; and
- ii) to develop a detailed Conservation Management Plan for the expanded Reserve."

Council staff have commenced the development of a comprehensive submission in line with Council's 2008 motion. This formal submission, which includes evidence of thorough planning processes and community support, will soon be forthcoming.

As such, Council is currently seeking a formal response from all Precinct Community Forums in Manly to assist in confirming community support for the proposal. Further support will also be sought from key user groups and the general public through the Mayoral column and local media.

The proposal was, and still remains, consistent with the stated objectives for North Harbour Aquatic Reserve, namely:

- To conserve representative habitats in a youthful tide dominated (drowned river valley) estuary in the Hawkesbury Bioregion;
- To conserve the biodiversity on rock platforms and subtidal reef habitats in the Sydney metropolitan area; and
- To assist in educating the public about marine conservation values.

In addition to this, the ongoing exclusion of commercial fishing from Sydney Harbour east of the Harbour Bridge due to high levels of residual pollutants in several fish species, removes one strong element of past resistance to the proposed expansion of the Aquatic Reserve. In relation to recreational fishing, Council is not seeking to prohibit this in any future Aquatic Reserve proposed for North Harbour.

Council looks forward to working with the Department of Environment & Climate Change to ensure the highly valued marine habitats of North Harbour are provided appropriate conservation management.

SUMMARY

This report provides Council with an update on the key projects planned for the Manly Environment Centre (MEC) in the forthcoming calendar year. The majority of this year's events and activities are centred around the year long partnership with the Manly Art Gallery through the 'Nature of Manly' exhibition. Additionally, the programme will involve working with various branches of Manly Council and engaging with other significant sectors including the Manly Historical Society, churches, the dive industry, surf clubs and Brookvale TAFE College.

BACKGROUND

Last year saw a very successful programme of significant improvements to the MEC shopfront resulting in a total reorganisation of resources and services. This has culminated in greatly increased visitation, volunteering, general interest and involvement. Display of new resources and a comprehensive "What's On" of environmental happenings attracts many passersby and an email list of hundreds.

This year will build on the results of the MEC's highly successful 2007 "The Art of Creating Habitat" program at the Art Sanctuary and the national launch of the Clean Energy for Eternity program when 5,000 people formed a human sign on North Steyne Beach at Ocean Care Day. The MEC also organised and managed many other well publicised and attended events. Three of these included the participation of federal and state government ministers.

These partnership activities will allow the MEC to increase its already significant market reach by putting the MEC in touch with a different audience; one attracted by events at the Art Gallery. Of course the MEC will continue to evolve and deliver its core offerings of information exchange, advocacy and research. This has been acknowledged by MEC's contact details for green tips being printed every weekday by the Manly Daily on page 2.

REPORT

With sustainability, climate change and other environmental concerns creating mainstream public and media interest, the MEC is well placed as an open to the public facility, responding to resident and visitor needs. The MEC continues to provide information and resources on local and global environmental issues, organise educational events and activities, assist researchers and students and provide community volunteer opportunities.

Many local residents look for ways they can become more involved in projects which champion environmental protection or address issues relating to climate change and sustainability. Over 100 active volunteers, community members and students are associated with MEC programs and activities.

Throughout a successful 2007 calendar year, the MEC developed and nourished many community partnerships. Partners included local community environmental groups, surf clubs, schools and Manly Council vacation care centres. The MEC also organised and managed many well publicised and attended events. Three of these included the participation of federal and state government ministers. Last year's activities culminated in a significant increase in the number of people

volunteering, seeking advice and making use of the many new resources. It is encouraging to see an increasing number of people proving feedback and information on ecological developments in their locality.

Major projects underway or to commence in the near future include:

- Managing and improving the public accessibility of the thousands of resources including multimedia, brochures, reports and other publications housed at the MEC;
- The supervision of general volunteers, undergraduate and postgraduate students and community service order volunteers, all working on projects and research relating to the important ecological and related issues in the Manly Local Government Area;
- Partnership projects or liaison with the Manly Art Gallery, Manly Council's Events staff and other divisions, Community Environment Partnership branch, NGOs, business and industry, churches, local professionals artists and sister environment centres. The MEC is also partnering with varied educational institutions in 2008 year including local schools, universities, TAFE and Manly's English language centres;
- Continual development of the MEC website to provide local, national and international environmental information and links in a virtual storefront;
- Researching and compiling a list of all Manly Council's environmental and heritage events, walks and talks and promoting them via the MEC's popular 'What's On'. The 'What's On' is a comprehensive list containing about 80 activities per month on the northern beaches and other areas. The "What's On" is distributed by email to hundreds of interested people and organisations, a hard copy is displayed on public view at the front of the centre; and
- Monthly activity summaries, statistics and other information on key events/projects organised by the Centre to report back to Council.

A list of the MEC's key events, activities and projects for 2008 is attached for the information of Council (refer to Attachment 1).

SUMMARY

Two submissions have been received for the Local Heritage Assistance Grants Scheme 2007/08, for conservation projects on a heritage listed property. The projects meet the heritage funding criteria and it is recommended that Council endorse the funding sought for the heritage conservation project.

REPORT

Background

Since 1995, Council has conducted an annual Local Heritage Assistance Grants Scheme. The Scheme provides funding to the owners of properties listed as heritage items under Schedule 4 of the Manly Local Environmental Plan 1988, for conservation projects.

The grant for any individual project presently ranges in value from \$250 to \$1,000.00. Suitable projects are generally visible from the street and may include painting, minor repairs or reinstatement of original detail.

The Council sought public submissions for grant funding in September 2007. One submission was received.

2007/08 Heritage Grants

The criteria for funding include all of the following:

- The property is a listed heritage item.
- The project will promote and encourage heritage conservation works.
- Works will involve items such as:
 - Replacement of significant built elements.
 - o Preparation of an authentic colour scheme; conserve or replace original elements.
 - Development consent must be obtained prior to commencing work.

The following submissions were received and based on the established criteria the projects are considered appropriate and worthy of receiving the grant funding sought.

SUMMARY

Council has elected to develop Estuary & Coastline Management Plans (EMPs and CMP's) for the coastal and harbour foreshore areas in response to legislative requirements and community issues in accordance with current best practice for the management of coastal and estuary foreshores.

Council received grant funding from the NSW Department of Natural Resources (DNR) (presently Department of Environment and Climate Change - DECC) to undertake the development of a Clontarf/Bantry Bay Estuary Management Plan.

The Clontarf/Bantry Estuary Management Working Group has overseen the process of formulating the EMP, and recommends that Council endorse the draft EMP for public exhibition. This document is circulated under separate cover (refer Attachment 1).

REPORT

Background

Council has elected to develop Estuary & Coastline Management Plans (EMPs and CMP's) for the coastal and harbour foreshore areas in response to legislative requirements and community issues in accordance with current best practice for the management of coastal and estuary foreshores.

Council received grant funding from the NSW Department of Natural Resources (DNR) (presently Department of Environment and Climate Change - DECC) to undertake the development of a Clontarf/Bantry Bay Estuary Management Plan.

The draft Clontarf/Bantry Bay Estuary Management Plan has been developed in consultation with the Working Group and form part of Council's wider coastal management planning process. Coastline/Estuary Management Plans have been developed for Cabbage Tree Bay, Manly Lagoon, Little Manly, Forty Baskets and Manly Cove study areas with similar documents currently being prepared for North Harbour.

The development of the EMP is identified in the Manly Plan 2007-2010. Preparation of this EMP fulfils implementation of Action C1.3.4 (undertake Estuary Management Plan for Clontarf and Bantry Bay coastline areas) of Manly Sustainability Strategy 2006. The Plan is linked to state targets set by the Natural Resources Commission (NRC) and regional targets set by the Sydney Metropolitan Catchment Management Authority (SMCMA).

The Clontarf/Bantry Bay Estuary Management Plan:

- translates the understanding developed in previous stages (through the development of the Estuary Processes Study and Estuary Management Study) into practical actions directed at improving the wellbeing of the estuary;
- reflects agreed position of regulatory authorities and interested parties in relation to the future conservation, rehabilitation and development of the estuary; and
- consists of a scheduled sequence of recommended activities that need to be undertaken to achieve the estuary management objectives.

Planning And Strategy Division Report No. 9 (Cont'd)

The Draft Clontarf/Bantry Bay Estuary Management Plan has taken a number of diverse considerations into account, including:

- implications of estuary planning policy and guidelines and local, regional and State planning instruments;
- the type and nature of hazards, including risk and potential damage to coastal developments and amenity;
- aesthetic, recreational and ecological values (through community consultation);
- social factors, including the needs and desires of the community; and
- long term considerations of climate change.

This Clontarf/Bantry Bay Estuary Management Plan sets 10 Goals and 35 Objectives to be addressed through 85 Management Options. Only 53 of these are new activities. Of these 53, 15 management options are proposed for immediate implementation, 25 within 2 years, 12 within 3-4 years and only 1 in later years. Overall, 22 management options have been rated to have high priority, 56 as medium priority and only 7 as low priority.

For the information of all Councillors, copies of the Final Draft of the Clontarf/Bantry Bay Estuary Management Plan have been circulated under separate cover (refer to Attachment 1). A summary of the Key Strategies is also appended as Attachment 2.

Community Involvement

To ensure wider community involvement into the development of the Plan, an extensive awareness campaign and consultation process was undertaken, in addition to the community based Working Group. Community and Stakeholder consultation was achieved through community/stakeholder field days, display panels, Council's webpage, and information in Precinct newsletters.

Community and user groups' survey forms were distributed through various means with a total of 120 survey forms returned. Two community consultation field days were held —Clontarf Reserve (21 October 2006) and Seaforth (12 November 2006).

Financial Implications

The total cost of implementing (including 1-5 years of operation and maintenance) all 85 management options addressing 10 key management issues is estimated to be \$ 2.10 million over a period of five years. As implementation responsibility of all proposed management options rests with a number of State Government agencies including Manly Council, funding responsibility will be shared.

An indicative total of \$410,000 will be required for 15 management options identified for immediate implementation, of which three are already partially funded. Funding from alternative sources outside of Council's budget will be necessary and is being explored. A list of possible funding sources has been prepared.

The adoption of the Clontarf/Bantry Bay Estuary Management Plan will greatly enhance Council's ability to seek external funding for the implementation of the various management options. For example, Council has already been successful in gaining funding of \$25,000 (to be matched \$:\$) under the State Governments Estuary Management Program for the implementation of a study proposed in this EMP.

Clontarf/Bantry Bay Estuary Management Working Group Recommendation

Introduction

The Clontarf/Bantry Bay Estuary Management Plan has been prepared under the NSW Government's Estuary Management Program. The Program is designed to fulfil the requirements of the NSW Estuary Management Policy 1992 and the NSW Coastal Policy 1997.

The draft Clontarf/Bantry Bay Estuary Management Plan has been developed in consultation with the Clontarf/Bantry Estuary Management Working Group. The Working Group has representations from the Manly Council, community Precincts, Government organisations (Department of Environment & Climate Change, NSW Maritime, Department of Primary Industries, and Department of Lands), Manly Council's Scientific Advisory Panel, neighbouring councils, local community and from the Aboriginal community. The EMP forms part of Councils wider coastal management planning process. Coastline/Estuary Management Plans have been developed for Cabbage Tree Bay, Manly Lagoon, Little Manly, Forty Baskets and Manly Cove study areas with similar documents currently being prepared for North Harbour.

The plan will coordinate management efforts of local government, state government agencies and community to address issues regarding the social, cultural, environmental, recreational and commercial amenity of the estuary.

A particular strength of the plan is the extensive and direct community and stakeholder engagement program employed to develop a schedule of achievable and targeted management actions. This extensive community and stakeholder participation generated wide support for the plan and provides a considerable head start towards achieving the estuary management goals.

Planning Implications

The development of Estuary Management Plan is identified in Council's Manly Management Plan 2007-2010 (MC 2007) and Sustainability Strategy 2006. The initiation of the Clontarf/Bantry Bay EMP has been indicated as part of the draft North East Subregional Strategy (E2.1) (DoP 2007).

Preparation of this EMP fulfils implementation of Action C1.3.4 (Establish a Community Working Group and undertake Estuary Management Plan for Clontarf and Bantry Bay coastline areas) of Manly Sustainability Strategy 2006.

Community Involvement

Many of the management strategies adopted for Clontarf/Bantry Bay estuary offer opportunities for community involvement particularly activities such as revegetation projects, monitoring programs and environmental education, as well as general monitoring of plan implementation and effectiveness. Local groups are therefore encouraged to take an active position in the management of their estuary, to liaise regularly with the community representatives on the Estuary Management Working

Group, and seek out opportunities wherever possible for community participation in implementation of the strategies adopted.

Financial Implications

Council has been successful in gaining funding of \$25,000 (to be matched \$:\$) under the State Government's Estuary Management Program for the implementation of a Sedimentation Process Seawall Stability Study proposed in the EMP.

The total cost of implementing (including 1-5 years of operation and maintenance) all 85 management options addressing 10 key management issues is estimated to be \$ 2.10 million over a period of five years. As implementation responsibility of all proposed management options rests with a number of agencies including Manly Council. Hence, adoption of this EMP does not commit Council to allocate immediate funding. A total of \$0.41 million will be required for 15 management options identified for immediate implementation. Funding from alternative sources outside of Council budget will be necessary.

The adoption of the Clontarf/Bantry Bay Estuary Management Plan will greatly enhance Council's ability to seek external funding for the implementation of the various management options.

SUMMARY

This report provides an update on the report to Council of 11 February 2008, concerning Sydney Water's major \$40-80 million SewerFix sewerage system capacity upgrades in the Manly-Warringah area between 2008-2010 based on information presented to Council officers and the community to date.

There have been concerns that, based on current information, the majority of the Sewerfix program for the Manly-Warringah area will not be within Manly LGA. This has led Council to write in Dec 2007 and Jan 2008 to: 1) the NSW Minister for Water Utilities, 2) Sydney Water's Managing Director, and 3) the Member for Manly, to request formal response to Council's concerns before proceeding further with program implementation.

Council staff have received an Addendum (of further information) to the Manly SCAMP Needs Assessment Report (2002) on 29 February 2008 and attended a meeting with Sydney Water representatives at the office of the Member for Manly, Mike Baird, on 19 February 2008. On 26 February 2008 council received an information leaflet outlining Sydney Water activities relating to Manly Lagoon. Sydney Water has also invited Council staff and key community representatives to attend a meeting and workshop regarding Manly Lagoon issues on the 10 March 2007.

REPORT

Background

Sydney Water is currently in the planning phase of a capital works program to be implemented between 2008-2010 to address and reduce major wet weather sewage incapacity issues and sewage overflow events into local waterways, creeks, lagoons, and beaches in the Manly-Warringah Area. Funded by an Independent Pricing and Regulatory Tribunal (IPART) NSW pricing determination in 2005, the program is coordinated under Sydney Water's SewerFix Alliance.

Sydney Water has previously presented to Council sub-committees on the need for SewerFix works to address incapacity and overflow issues in Manly, including previous presentations that expenditure of \$45 million would be required to upgrade sewerage infrastructure around Manly Lagoon to meet Sydney Water's licence requirements.

There have been concerns that, based on Sydney Water's new hydraulic models and current information, Sydney Water now states that there are no major wet weather overflows in Manly. As such, the majority of the program for the Manly-Warringah area is now being directed outside of the Manly LGA.

It is Council's position that without adequate explanation for the contradiction between new hydraulic modelling results, and, previous modelling results and historical evidence, it is premature to plan SewerFix works and expenditure, hence Council cannot support the program.

In December 2007 and January 2008, Council formally wrote to: 1) the NSW Minister for Water Utilities, 2) Sydney Water's Managing Director, and 3) the Member for Manly, to request formal response to Council's concerns before proceeding further with program implementation.

Planning And Strategy Division Report No. 10 (Cont'd)

Council has now received an Addendum to the *Manly SCAMP Needs Assessment Report (2002)* on 19 February 2008, and attended a meeting with Sydney Water representatives at the office of the State Member of Manly, Mike Baird on 19 February 2008. On 26 February 2008 Council also received an information leaflet outlining Sydney Water activities relating to Manly Lagoon.

Latest Information Received by Council

At the meeting of 19 February 2008, Sydney Water representatives indicated Sydney Water has carried out detailed assessments of the Manly SCAMP *Needs Assessment Report* 2002 report, showing that the frequency of overflows for 4 sewer overflows locations in Manly LGA quoted in this original hydraulic modelling report were substantially overestimated. Council staff noted the occurrence of high sewage levels in the lagoon in independent scientific water quality monitoring. Sydney Water noted that a high-frequency and high-volume overflow in Brookvale that enters the lagoon via Brookvale Creek had been tracked, and is responsible for delivering significant sewage loads into the lagoon.

Council received an addendum to the 2002 SCAMP on 19 February 2008. The addendum highlights that re-gauging, re-modelling and site inspection has been undertaken to result in a revised spill frequency estimate. Council's Water Cycle Management Team is currently reviewing the document.

An information leaflet outlining Sydney Water activities relating to Manly Lagoon was also received by Council on 26 February 2008. The leaflet further indicates that overflows in the Brookvale area are the main cause for sewer pollution incidences in the Manly Lagoon catchment and that \$55 million will be spent on supplementing the Narrabeen sub-main [major northern beaches sewer main] as part of the Wet Weather Overflow Abatement Program 2007-2012, to benefit Manly and Curl Curl Lagoons.

The information leaflet also outlined a dry weather water quality program to help determine the contribution of sewage overflows to *faecal coliform* contamination to Manly Lagoon. The leaflet indicates Sydney Water will be commencing a program to investigate the occurrence and extent of overflows at Seaforth entering the lagoon via Burnt Bridge Creek catchment.

Council's Water Cycle Management Team will be carefully reviewing these documents and proposed programs, as well as accepting the invitation of Sydney Water/ Sewerfix Alliance to discuss these results in more detail. A workshop regarding Manly Lagoon issues with Sydney Water has been scheduled for 10 March 2007, for Council staff and key community representatives to attend.

RECOMMENDATION

It is recommended that Council:

- 1. Receive and note the information;
- 2. Receive further updates on Sydney Water's SewerFix program progress and program implementation as information becomes available.

SUMMARY

Council resolved at the Ordinary Meeting of 18 December 2006:

"That reports to both Planning & Strategy and Ordinary Meetings of Council include a short report, preferably in a standard format, on staff's assessment of the Triple Bottom Line implications of proposals contained in the report."

The purpose of this Council report is to provide a response to Council's question without notice (QWN1/08) by providing details of the implementation strategy.

This report goes further to explain Triple Bottom Line (TBL) Reporting, the supporting policy context, the benefits and how TBL Reporting will be implemented for Council reports from May 2008, to allow staff training to be undertaken.

REPORT

Brief Introduction to Triple Bottom Line Reporting

TBL Reporting has been developed by the business sector as a means of reporting on social and environmental implications in addition to the traditional financial bottom line. TBL Reporting is closely associated with sustainability reporting since it addresses the three elements that are often used to describe the integrated nature of economic, environmental and social elements of sustainability. Ultimately, TBL Reporting is a tool for implementing sustainability principles into day-to-day council business.

Policy Context

TBL Reporting is supported by direction in guiding legislation and policy documents:

- The Local Government Act, 1993 Council Charter in NSW is for Councils "to have regard to the long term and cumulative effects of its decisions"
- The Manly Sustainability Strategy has an action to "continue implementing triple bottom line reporting and assessing initiatives to review and improve..."
- The Manly Plan 2007-10 states that "Council is undertaking a full review of our current TBL reporting to further integrate the TBL process into Council operations to assist in improving the sustainability outcomes of operational decisions."

Benefits of TBL Reporting

TBL Reporting results in more transparent and informed decision-making, whereby environmental, social and economic implications of these decisions are fully considered. Benefits of TBL Reporting include:

- Increased Transparency and Accountability;
- Increased awareness of the social, environmental and economic implications of proposed actions for staff and Councillors;
- Full Consideration of Economic, Social and Environmental Factors; and
- Informed Decision-Making.

Planning And Strategy Division Report No. 11 (Cont'd)

Proposed TBL Reporting Framework

The TBL Reporting Framework will ensure that reports that are likely to have social, economic and environmental implications include a TBL Assessment. Reports that are administrative in nature will not be required to conduct a TBL Assessment. The screening criteria (refer to Attachment 1) will be in place to guide staff on whether the report they are writing should include a TBL Assessment and use the TBL Report format.

The TBL Report headings in Table 1 ensure that the social, environmental and economic implications are documented.

The new TBL Report format will include optional headings for customer service implications and consultation. Customer service implications recognises that as an organization that provides services to the community it is often important to consider whether the proposed actions will increase or decrease Council's ability to provide customer service to the public, stakeholders and other areas of Council. The consultation implications heading is designed to outline what consultation has been undertaken or is proposed as part of the decision-making process. This may include the public, relevant stakeholders, government bodies or branches of Council.

Implementation of TBL Assessment and Report Format

To assist Council staff in conducting TBL Assessment, "TBL Assessment Questions" have been developed and are included as Attachment 2. In addition, Council staff with sustainability experience and training will provide, as needed, training and advice to Council staff on TBL Reporting. It is a recommendation of this report that TBL Reporting be scheduled to be undertaken as part of reports to Council's Planning and Strategy and Ordinary meetings from May 2008, to allow time for staff training to be undertaken.

Implementation Monitoring of TBL Reporting

To monitor the effectiveness of TBL in Council reports a bi-annual implementation and monitoring review will be undertaken by Council's Sustainability Planner. This process will involve reviewing reports to Council, reviewing information in the TBL headings and working with staff to improve the function and effectiveness of TBL Reporting. Implementation monitoring results will be reported to the Manly Sustainability Strategy Management Group.

Incorporating TBL into Council Reports is one step towards integrating the Triple Bottom Line into Council's reporting and decision-making. To move towards sustainability requires not only reporting of what has occurred but also a pro-active approach from which social, economic and environmental implications of decisions are considered.

Planning And Strategy Division Report No. 11 (Cont'd)

CONCLUSION

TBL Reporting is a reporting device and/or an approach to decision-making that can be applied across council activities. In the future Council staff will investigate the merits of integrating TBL decision-making in other specific areas of Council's activities.

RECOMMENDATION

- 1. That, commencing in May 2008, Council staff use Triple Bottom Line Reporting for both Planning & Strategy and Ordinary Meetings of Council in accordance with Council's recommendation from 18 December 2006.
- 2. That Council staff monitor the implementation of Triple Bottom Line Reporting and report to the Manly Sustainability Strategy Management Group.
- 3. That Council staff continue to identify opportunities to improve Triple Bottom Line Reporting and decision-making at Council.
